The Board reviewed and discussed the Policy and Procedure Manual. Motion by Morgan, 2nd by Helwig to eliminate the Finance Committee and advise the Administration Committee of needed financial duties and responsibilities. The roll call vote was as follows: Nyberg – no; Bassett – absent; Voight – no; Kinsley – yes; Buckholtz – no; Dennis – no; Schleeter – yes; McCoy – no; Shuman – yes; Morgan – yes; Schlender – no; Helwig – no; Duffy – no; Paulsen – no; Bisonette – yes. The motion failed with 5 voting yes and 9 voting no.

Under Voting and Procedure, the button is not red, change to activate the red light on microphone.

Motion by McCoy, 2nd by Kinsley, to approve the appointments to the seven standing committees, with the Finance Committee to be developed. Motion carried

The Board discussed appointments to the adhoc committees, changes, and possible needed revisions to the board rules. Representative for Aging and Disability Resource Center of the North needs to be a Health and Human Services board member. Supervisor McCoy will be appointed in place of Supervisor Paulsen. Sawyer County/LCO Joint Committee needs two members, add Supervisor Schlender. Board rules state three appointed board members on Transit board. Need to review Transit by laws to see if Hal Helwig can be the third member. Economic Develop Corporation should be one appointed board member-take off Supervisor Morgan. Visions Northwest states one appointed board member-Can Lynn Fitch represent the county? Take Supervisor McCoy off Senior Resource Center and replace with Supervisor Morgan. Supervisor McCoy requested to be on the Hayward Library Board. Supervisor Paulsen agreed to come off the Library Board and replace with McCoy. Motion by Duffy, 2nd by Kinsley, to approve the appointments to the adhoc committees with the stated changes. Motion carried

Supervisors were provided the Sawyer County Policy Statement and Terms regarding the county issued tablets. Information Technology Director Mike Coleson did a brief overview of the tablets with the County Board. County Clerk Carol Williamson explained the voucher to receive payment of per diems and mileage reimbursements. County Administrator Tom Hoff reminded the board Committee Chairs would be elected at the May Committee meetings.

Motion by Nyberg, 2nd by Duffy, to hold a listening session at the Winter School. Duffy rescinded his 2nd. Motion by McCoy, 2nd by Helen, to hold a listening session earlier in the fire hall. Motion by Helwig, 2nd by Schlender, to hold the listening session on Wednesday, May 16, at 6:30 pm at the Winter Fire Hall. Motion carried
