The following conditions shall be met during construction or installation and prior to occupancy or use:

- 1. SPS 382.40(4)(c)1.** Control valves shall be installed in water distribution systems serving public buildings as specified in this subdivision.
- 2. SPS 382.31(3)(b).** Each gravity flow sewer shall be provided with at least one three-inch main stack.
- 3. SPS 382.41(3)(a)1.** Potable water supply systems shall be protected against contamination due to cross connections or backflow conditions by one of the methods or devices specified in Table 382.41-1 or 382.41-2. Provide ASSE 1019 frost proof automatic draining anti-backflow vacuum breakers at exterior wall hydrants.

REMINDER(S)

- **SPS 382.20(8)** The plumbing system shall be installed in accordance with approved plans.
- **SPS 383.22** Plan review and approval. This approval does not include the private onsite wastewater treatment system. Refer to SPS 383.22 for requirements on POWTS submittals.

- **SPS 384.10.** No fixture, appliance, appurtenance, material, device or product may be sold for use in a plumbing system or may be installed in a plumbing system, unless it is of a type conforming to the standards or specifications of chs. SPS 382, 383 and 384 and ch. 145, Stats.
- As of today's date, a refund in the amount listed in the FEE portion of this letter has been initiated and forwarded to a manager for review. The refund will be made under separate cover. Please expect a 6-8 week time period for fiscal processing. Refunds will be made to the payer.

A full size copy of the approved plans, specifications and this letter shall be on-site during construction and open to inspection by authorized representatives of the Department, which may include local inspectors. If plan index sheets were submitted in lieu of additional full plan sets, a copy of this approval letter and index sheet shall be attached to plans that correspond with the copy on file with the Department. If these plans were submitted in an electronic form, the designer is responsible to download, print, and bind the full size set of plans along with our approval letter. A department electronic stamp and signature shall be on the plans which are used at the job site for construction. All permits required by the state or the local municipality shall be obtained prior to commencement of construction/installation/operation.

In granting this approval the Division of Industry Services reserves the right to require changes or additions should conditions arise making them necessary for code compliance. As per state stats 101.12(2), nothing in this review shall relieve the designer of the responsibility for designing a safe building, structure, or component.
