This permit allows one passenger to accompany permit holder to act as an assistant. The passenger must accompany the permit holder at all times and is not permitted to take part in the activities described on this permit under any circumstances and may act as an assistant only if named below. Please provide the name and address of potential assistants.	

TERMS AND CONDITIONS:

1. This Permit may only be issued to those applicants holding a Class A, Class B (if issued for greater than one year), or Class C disability permit and those in possession of a DMV Disabled Parking Permit from the State of Wisconsin. If you are not in possession of a Class A or Class C disability permit, you must first apply for and obtain one from the State of Wisconsin.
2. This Permit must be in the applicant's possession while operating a motor vehicle under the conditions for this Permit. A copy of this permit must also be displayed in a visible fashion on the dash of any vehicle parked at the access point.
3. Permits may be issued for established roads and trails only. Cross-country travel is not allowed.
4. Permits are issued for a specific access to and from a point, not for a general area. Motor vehicle travel is only allowed on the route defined on the map, which is made part of this document.
5. If the approved access is through a gate, the permittee will provide a lock, which will be locked into the County Forest lock. This will allow for access for both the permittee and County Forest personnel.
6. Vehicles used under this permit may not be operated in excess of normal walking speed (2-3 miles per hour).
7. The permit holder is allowed one passenger to assist his or her activities. This passenger is not permitted to participate in the activities for which this motorized access is desired. For example, if the permittee has applied for hunting access, the passenger may assist but not hunt.
8. Permit may be issued for any legal activity on the County Forest, but access may be restricted seasonally or for other pertinent reasons. Permits will automatically be suspended from April 1 to May 15.
9. Sawyer County may deny any permit application in cases including, but not limited to, potential for environmental damage, active timber sales, sensitive areas, and safety concerns.
10. Violations to the terms of this permit will automatically render this permit null and void and subject the permittee to the terms of the Sawyer County Owned Land Ordinance and corresponding citations and forfeitures.
11. The permit holder hereby agrees to not damage any trees or other vegetation by use of his/her motorized vehicle and shall be responsible for any damage that may occur, including fire suppression.
12. The permit holder must carry this permit whenever exercising this privilege.
13. The permit holder must occupy the permitted vehicle.
14. The county reserves the right to restrict the type and size of the vehicle.
15. Permit holder must abide by all state laws and county ordinances.
16. The Permittee shall hold harmless Sawyer County from any liability from damage to life or property arising from the Permittee's use of Sawyer County lands under this permit.
