James Schlender called the meeting to order at 7:36 a.m.

Criminal Justice Coordinator Diane McNamer updated the Council on the Opioid and Meth conference held in Columbus Ohio. Attendees came from six states. Judge Yackel, Sheriff Mrotek and McNamer attended from Sawyer County. Drug related death rates are very high in Wisconsin. The Council discussed mental health access to inmates in the Sawyer County jail. An inmate, staff, or doctor can request a consultation.

Adopting Traffic Code and Ordinance Bond Schedule tabled to a future meeting date.

Lieutenant Joe Sajdera provided the CJCC with Electronic Monitoring/Home Detention Criteria, an Electronic Monitor Pre-Approval Checklist, Electronic Monitor Rules, and Jail division Policy and Procedure. Some eligible inmates cannot afford electronic monitoring.

Proxy update will be on future agenda.

McNamer started applying patches March 12 in place of oral swab testing.

McNamer provided updates on the job skills culinary academy offered by Northwest Wisconsin Workforce Investment Board. Seven started the program; down to four due to Huber violations. Eleven individuals participated in the Prime for Life Diversion program last month. The cost of the program is \$200 and paid by the individual. Cases dismissed after completion of the course. A second course is starting April 23.
