Call to Order – Chair James Schlender called the meeting to order at 12:00 pm.

Certification of Compliance with the open meeting law was met. Roll Call was taken. Quorum was met.

Public Comments

Minutes from previous meeting – A motion was made by Mr. Hoff; second by Lt. Johnson to accept the minutes of the September 9, 2021, meeting as presented. Motion carried without negative vote.

Criminal Justice Coordinator update – Ms. Fisher advised that the TAD planning grant has been submitted. There are currently 79 individuals on pre-trial supervision, 8 on electronic monitoring, 140 on a waiting list, and 0 on alcohol monitor. DA Poquette is mailing approximately 50 referral letters to legal defense counsel of charged individuals, requesting meetings be initiated with JusticePoint, potentially qualifying them for a pilot diversion process. It is a 4-step process that could avoid felony convictions and resulting fines, reduction of sentence or dismissal.

Judge Yackel requested that the hall kiosk be reviewed as a potential daily test option for some individuals as a condition of bond. Lt. Johnson will begin the process of getting the kiosk programmed and arrange training.

2022 Budget Status – Mr. Hoff reviewed the Administrator’s budget being presented to County Board. The budget includes a \$50,000 contribution from the Tribal Governing Board for the JusticePoint program and a \$173,000 tax levy that funds the rest of the public safety budget.

Community Services Update – Mr. Hilgendorf reported that the Greater Hayward House of Hope is full at four residents; one has graduated from the program. The women’s home has five residents with a sixth joining soon. The newly vacated Element Church building on Main Street will be used to house the men’s program director and one resident. Due to the change in the meeting date, representatives of the LCO men’s and LCO women’s shelters were unable to attend today.

Meeting Date/Time – The next meeting of the Criminal Justice Coordinating Committee will be Wednesday, December 1, at 12:00 pm in the Assembly Room.

As of this morning, 11/23/21, we have 6 people on electronic monitoring (none on alcohol monitor), 70 people are on pretrial supervision, 4 people are on diversion, and we have filed over capacity memos on 160 people. We are anticipating a rush of people to screen for diversion.
