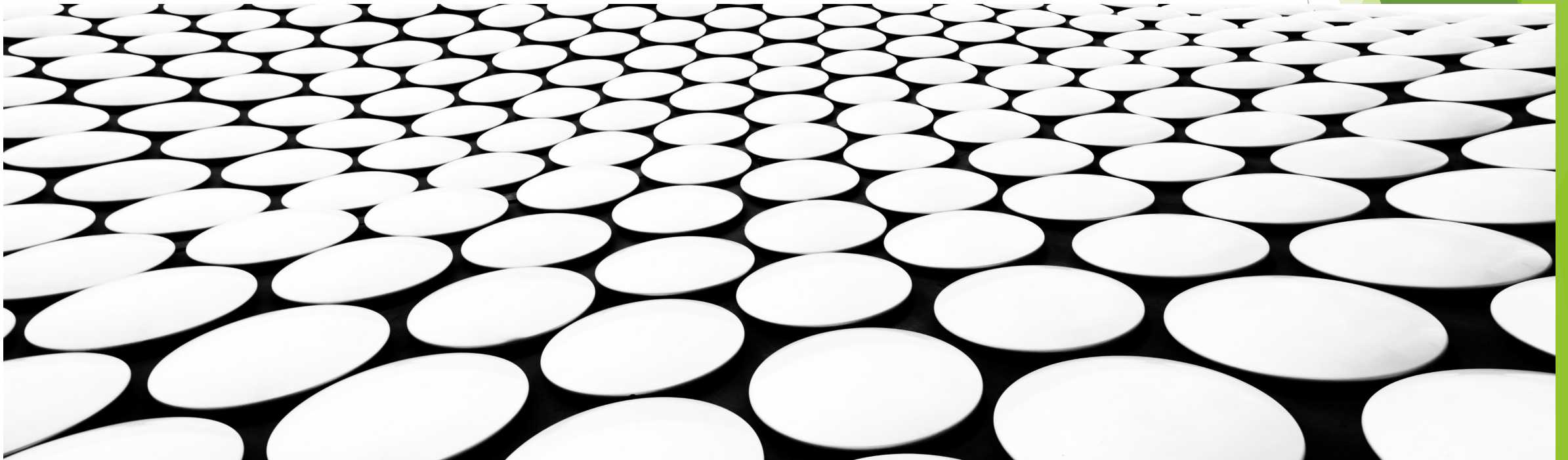


Sawyer County Standing Committee Appointments
