A motion was made by Mr. Nies to recommend approval of the draft to the County Board with adding impaired waters map, 2<sup>nd</sup> Mr. Olson. Discussion continues as whether to add bike map. Amended on the floor to add bike map. A roll call vote was taken and failed 3:3. Aye votes included Nies, Wilson and Kelsey; Nay votes included Zillmer, Olson and Kemp. Amended motion fails

Original motion withdrawn. New motion by Mr. Nies to recommend approval of draft to County Board with adding impaired waters map 2<sup>nd</sup> by Ms. Zillmer. Discussion continues as to add text language. Motion was amended by Mr. Nies to include text language with impaired waterways map. second by Ms. Zillmer. Motion carried 6:1.
