Ron Kinsley called the meeting to order at 6:30 pm.

1. Approve agenda and additions

Motion by Shuman, second by Schleeter, to approve the agenda. Motion carried.

2. Approve minutes from December 11, 2013 and December 19, 2013 Highway Committee Meeting

Motion by Thompson, second by Shuman to award the bid to Lulich Implements per the recommendation of Jay Sands, Shop Foreman, for the purchase of (1) New Holland T6155 and (1) New Holland T6030 Plus. Motion carried.

5. Discuss SMA for the STH 77 and CTH K/Mosquito Brook Intersection

Gary provided another update this month regarding the State Municipal Agreement (SMA) for the STH 77 and CTH K/Mosquito Brook Road Intersection WisDOT Highway Safety Improvement Program (HSIP) project. Last month he informed the committee he was not comfortable with the "no cap" language and was not signing the proposal until further clarification. The updated agreement is attached. Gary recommended that the Town of Hayward sign the corrected agreement.

Motion by Schleeter, second by Shuman to approve authorization to sign the State Municipal Agreement proposal (SMA). Motion carried.

6. Discuss Fund Balance Report

The committee reviewed the funds balance report for November 2013 and the overtime report for the year. Winter maintenance costs were reported extremely high this year in comparison to last year due to the weather conditions. The State has reimbursed the Highway Department for expenses through October 2013.

7. Commissioner's Report

Highway crew has been working on snow and ice control as well as shoveling bridges. There are no workers compensation injuries to report. Due to the forecasted extreme cold temperatures and wind chill the crew was directed not to report to work on Monday, January 6, 2014.

Motion by Thompson, second by Shuman to approve the Commissioner's Report. Motion carried.

8. Old Business

Mike Coleson, IT Department, installed a scanner for Teresa McCue, Account Clerk. All accounts payable invoices were scanned and attached to the payables in NewWorld this month. It was a time consuming process that will have to be evaluated to make sure it can be done in a timely matter. Follow up discussions included accounts payable new vendor entry and address changes, invoice scanning and employee paystubs.

9. Other matters for discussion only

One of the security camera's at the Highway Department stopped working properly this morning. Digital Security Systems was contacted and plans to resolve the issue next week. An excessive amount of LP fuel has been used at the Winter and Radisson shops. Tanks were tested and no issues were reported. Como Oil will be installing monitors on the tanks and phone lines to notify them of current inventory levels at the shops. It was recommended that Gary contact Tim Hagberg, Maintenance Department, regarding installing programmable thermostats at the shops.
