

**RESOLUTION AUTHORIZING MEMORANDUM OF UNDERSTANDING
BETWEEN SAWYER COUNTY AND THE TOWN OF RADISSON
REGARDING PIPESTONE TOWER ROAD**

WHEREAS, Wisconsin law permits Sawyer County (the “County”) to enter into certain agreements to share services and obligations with other municipal entities;

WHEREAS, the County owns a radio communications tower (the “Tower”) located in the Town of Radisson (the “Town”);

WHEREAS, the Tower is accessed by a Town road, known as Tower Road, also known as Pipestone Tower Road (the “Road”);

WHEREAS, the County and the Town have reached an agreement regarding the maintenance of the Road, which is set forth in a Memorandum of Understanding, a copy of which is attached hereto and incorporated herein as Exhibit A;



WHEREAS, the Town approved the terms set forth in the Memorandum of Understanding at its Town Board meeting on October 14, 2019;

WHEREAS, the Memorandum of Understanding was reviewed and discussed by the County Public Works Committee at its meeting on November 6, 2019, and the County Public Works Committee thereafter voted to recommend to the County Board of Supervisors that the County Board of Supervisors approve the Memorandum of Understanding.

NOW, THEREFORE, BE IT RESOLVED, the Sawyer County Board of Supervisors determines the following:

1. Approval of Agreement. The Sawyer County Board of Supervisors hereby approves the terms of the Memorandum of Understanding as set forth in Exhibit A.
2. Health, Welfare and Safety. The grant of the Memorandum of Understanding and the terms set forth therein are beneficial to the health, welfare and safety of Sawyer County’s residents, taxpayers and visitors.
3. Additional Actions. The Sawyer County Clerk, or the Sawyer County Clerk’s designee, shall take all necessary steps to ensure that Sawyer County Board of Supervisor’s action and decision set forth herein is completed.
