8 **WHEREAS**, The Sawyer County Comprehensive Plan in accordance with state statutes must be
9 amended at least once every 10 years and the initial plan was adopted in 2010. The update will include
10 revisions to all plan text, statistical and projection data, maps, goals, objectives, policies and actions, meeting
11 attendance and distribution or required information to adjoining and overlapping jurisdictions as specified
12 within WI State Statute 66.1001 and the previously adopted public participation plan.

14 **WHEREAS**, approval of the contract between Sawyer County and Northwest Regional Planning
15 Commission was already granted by the Board of Supervisors.

17 **WHEREAS**, there is substantial common aspects of this update that require a unique citizens
18 group to accomplish.


